• Maintaining a complete oiling and lubrication schedule as directed by supervision.

• Multicraft Technicians will also be responsible for all centrifuging and filtering operations that include moving, setting up, operating, and cleaning the centrifuge and filters, as directed by supervision.

• Multicraft Technicians will report to supervision any need for supplies and any unusual conditions that exist during the workday.

• Multicraft Technicians may also be required to drive company vehicles on plant property. They are responsible for handling the necessary paperwork, keeping their work area clean and notifying Supervision of any problems encountered in their operation.
