

Technical Regulations Analyst (TRA)

Feladatok

The Technical Regulations Analyst is responsible for enriching the objects, provided by the TRC, in the requirement management tool with BA/Group sector-specific information to make efficient requirements development possible.

As needed, inform the Technical Regulation Coordinator (TRC) and Technical Regulation Manager (TRM) about required external standards and legal technical regulations to be searched for and, if known, the sources.

Main tasks:

- Inform TRM about potential sources that should be considered in the scanning process (e.g. identified within a project)
- Support TRC to identify suitable Technical Regulation Analysts (TRA) and allocate the objects in the specific tool to manage requirements to them
- Evaluate the potential relevance of external standards and legal technical regulations for the products and technology in the area of responsibility.
- Add BA-specific data (e.g. technology grouping) to each object within the specific tool to manage requirements
- Decide with the support of TRC/TRE if further support from a legal counsel is needed and flag it respectively
- Creation of interpretation (if found necessary)
- Support TRC to create changelog & communicate to projects & product responsible
- Support TRC to provide enriched data including interpretation, if existing to projects & product responsible
- Collaboration with the respective TRAs (e.g. cross BA Network) and the TRC&TRM
- Support the projects (e.g. Requirements Engineer) identifying the project relevant for external standards and legal technical regulations (e.g. tC project counsel).
- Give guidance by requirement implementation
- Be contacted for advice in case of uncertainties regarding tC requirements
