In this capacity, the ESH Intern will contribute to successful operations for the location. This position is scheduled to last 12 weeks in length from May 18, 2026 - August 7, 2026.

### RESPONSIBILITIES:

- Evaluates the work environment for occupational safety, environmental protection, fire protection, security and health.
- Assist with the development and implementation ESH related processes in the location to ensure legal compliance as well as emergency response planning/execution.
- Conduct occupational safety checks before start of operation of equipment and machines.
- Utilize Risk Assessment methods to generate safety analyses and concepts as well as emergency preparedness plans.
- Aid management in program elements to ensure compliance with all local, state and federal regulations regarding control and disposal of waste.
- Assist with emergency response planning and execution.
