general management

- coordinate all IT activities for the plant
- support the translation of plant IT strategy into action plans and ensure implementation
- contribute to strategic and operative planning of the plant (e.g. with respect to investments, capacity and headcount planning)
- support the achievement of IT targets according to internal and external customer expectations

- ensure operation, support and maintenance of plant IT infrastructure (software, clients and servers, IT service desk, desktop, server and mail service management, network and other physical equipment as e.g. printers, scanners, etc.) according to standards
- ensure operation of local plant data centers (facility management, fire protection, security control, backup, etc.) and implement a contingency plan
