- Relay work orders to service managers to complete service request.
- Start work orders and invoice as required.
- Assist in verifying all incoming and outgoing product for accuracy in terms of amount, size, and type, informing management of inventory and supply shortages as well as assisting in actual periodic inventory counts
- Ensure all administrative paperwork concerning delivery orders required to move with shipments is available for inspection and that appropriate paperwork accompanies delivery
- Abide by all Company safety policies and state and federal transportation regulations
- Reconcile monthly inventory.
- Process and administer inventory receiving and deliveries
- Assist in quarterly inventory while maintaining security of products and control measures.
- Must be available to work rotating shifts, potentially nights and occasional weekends.
