Cyber Security Architect

- Requirements Engineering
- Definition of the security architecture and review of the system architecture
- Coordination of customer requirements as well as the security and privacy concept across disciplines (SE, SW, HW, test, production)
- Coordination of the required security-relevant steps during the production of the ECUs (e.g. Writing of key material)
- Creation and maintenance of the SP plan and the SP case
- Management and status tracking of all security activities in the project
- Preparation of customer assessments and Continental's internal security assessments
