1. 2. Checking parts / process at beginning of shift, in-process and end of shift to assure adherence/conformity based on the Quality Plan (Inspection Instructions, Work Instructions, SOPs, etc.). Conducts in-process sampling and physical testing of product with required paperwork. Prepare and provide inspection reports for measurements performed as needed.
3. Give disposition and control of non-conforming material. Escalate as necessary and support Production in containment(s) as need.
