Your tasks

Using a forklift, hand truck, and other machinery, count and place items for storage and access. Move material around as needed, and deliver outgoing materials to the Warehouse area as necessary. Ensure line is stocked with necessary parts to meet production requirements by using Bill of Materials (BOM) and computer software.

- 2. Utilize material software systems to provide material for production and hand held scanners to track lots.
- 3. Understand and follow production schedule/shipment boards.
- 4. Interpret and use correctly Bill of Materials (BOM).
- 5. Apply 5S principles to increase efficiency and effectiveness in assigned work area.
- 6. Clean station at scheduled PM and additionally as needed.
