- Perform inbound and internal inspection and test of materials including visual or with various hardware, fixtures, and gauges, based on Inspection Instruction/Plan, criteria established in specific failure catalogue (including appearance, surface defects, debris, shards and similar) or under orientation of a Lead Inspector.
- 2. Checking parts / process at beginning of shift, in-process, and end of shift to assure adherence/conformity based on the Quality Plan (Inspection Instructions, Work Instructions, SOPs, etc.).
- 3. Conducts in-process sampling and physical testing of product with required paperwork. Prepare and provide inspection reports for measurements performed as needed.
- 4. Proper containment and control of non-conforming material. Escalate as necessary and support Production in containment(s) as need.
- 5. Performs other duties assigned by Lead Inspector or Quality Coordinator, for example, perform MSA Studies as an appraiser.
