- Responsible for change over activities.
- Perform work on electronic, mechanical, and pneumatic/hydraulic systems performing PM's and making repairs under the guidance of Lead Technicians and Mentors.
- Assume a responsible role in the output and quality of equipment in your area.
- May be required to setup and use ladders and hand and power trucks.
