General legal advice:


- Handling legal issues and advising on national and international matters of all ContiTech companies in the Region, embedded in a global team of lawyers

- This includes both individual contractual provisions from specific business transactions and framework and standard contracts for new business transactions.
- Comprehensive legal advice on ongoing contractual relationships, including national and international supply and service relationships.

- Independent advice on the planning and implementation of basic action structures, including ensuring by drafting guidelines, instructions for action and processes
- Analysis, evaluation and preparation of standard legal documents, model contracts and general terms and conditions as well as their adaptation to new legal frameworks
