- Follow current legal developments.
- Professional support of legal colleagues in other jurisdictions in the aforementioned area of responsibility.

- Drafting, negotiation, review and interpretation of all contracts typical
  of companies (including contracts of particular strategic importance)
  in cooperation with the (operational) specialist departments /
  divisions in German and English, even in complex projects with
  outstanding importance and required expert knowledge
- This includes both individual contractual provisions from specific business transactions and framework and standard contracts for new business transactions.
- Comprehensive legal advice on ongoing contractual relationships, including national and international supply and service relationships.
