- This includes both individual contractual provisions from specific business transactions and framework and standard contracts for new business transactions.
- Legal advice on ongoing contractual relationships, including national and international supply and service relationships.

Standardization:

- Independent advice on the planning and implementation of basic action structures, including ensuring by drafting guidelines, instructions for action and processes
- Analysis, evaluation and preparation of standard legal documents, model contracts and general terms and conditions as well as their adaptation to new legal frameworks

Claim Management:

• Ensuring, managing and monitoring the defense and enforcement of civil law claims, including civil and criminal court proceedings as well
