- Work with Mixing Management Systems (MMS)

- Possess and apply problem solving skills in case of machine cycle issues
- Operate forklifts and operate other material handling equipment as needed and is responsible for the proper care and safe operation of the material handling equipment.
- Follow recipe weight measurements and ensure accuracy
- Read specifications, use hand tools, and gauging devices, to monitor current and ongoing product quality
- React quickly to equipment downtime or other extraordinary condition, and must notify supervision whenever such conditions occur
