- Connect financial and non-financial reporting obligations in alignment with financial reporting team
- Maintain the network for sustainability accounting and reporting and serve as reliable partner for social and financial matters
- Manage the overall assurance process for sustainability reporting including effective audit planning, monitoring, audit execution and escalations within the given timeline
- Handle key risks from definition to report integration for effective audit trails.
- Act as substitute for the head of sustainability reporting
