The Compliance Officer will lead all ongoing activities in Brazil related to the implementation of Continental Tire's Compliance Management System (CMS). The Compliance function consists of four Compliance core areas: Business Ethics, Anti-Money Laundering (AML), Antitrust, and Data Compliance, including but not limited to the operationalization of the Compliance strategy.

The Compliance Officer will be part of the Americas (AMS) Compliance team. In this key role, the Compliance Officer will provide expert advice and support to the business on a broad range of Compliance matters. The role is instrumental in helping to prevent, manage, and mitigate Compliance risks, including the potential for regulatory penalties and fines. The Compliance Officer will also be responsible for monitoring and advising on Data Privacy practices to ensure adherence to all applicable laws, regulations, and internal policies across the business and functions.

Serve as a first contact point regarding all Compliance subject matters for all the locations in Brazil.

Interface between all Brazilian locations, the Americas (AMS) Region, and the other global Compliance departments.

Collaborate continuously with the global Compliance team and embrace global compliance initiatives (e.g., trainings, communication, and integrity culture).

Continuously support the improvement of design and implementation of the CMS, especially considering the local aspects and applications, including Data Compliance.

Ensure the effectiveness of compliance measures in the Compliance cycle.

Provide legal advice on data compliance issues for all stakeholders (day-to-day advice), by supporting the first line of defense.

Implement and manage processes and standards to ensure the legally compliant treatment and documentation in the event of data subject requests (deletion and/or information requests).

Support the identification and assessment of data protection risks and provide adequate solutions for the business.

Support the prevention, detection, response to, monitoring and reporting of data protection breaches.
