The Warehouse Associate will assist the Retail Manager at a commercial tire facility. Primary duties include driving medium to heavy weight trucks short and long distances to deliver a variety of products to customers in compliance with all Company safety policies and state and federal transportation regulations. This position functions in a manufacturing environment at a commercial tire facility.

Essential Duties:

- Designate and organize the warehouse stock by product line and by physical alignment, allowing sufficient space for overflow
- Load and unload delivery trucks requiring physical moving and lifting of product weighing as much as 100 pounds
- Timely transportation of product from origin to destination as assigned
- Serve as back up delivery drivers when needed to transport stored items from warehouse to plant or to pick up items from several locations for shipment.
- Assist in verifying all incoming and outgoing product for accuracy in terms of amount, size and type, informing management of inventory and supply shortages as well as assisting in actual periodic inventory counts
- Ensure all administrative paperwork concerning delivery orders required to move with shipments is available for inspection and that appropriate paperwork accompanies delivery
- Maintain professional representation of the Company in all interactions with customers and through responsible driving
- Maintain records required for compliance with state and federal regulations, including driver's logs, records of fuel purchases, mileage records and other records required by law and Company policy
- Abide by all Company safety policies and state and federal transportation regulations
- Operate powered industrial vehicles (forklifts, pallet jacks, order pickers, etc.) in safe manner and maintain an operator license, if required
- Perform periodic facilities maintenance and/or custodial/housekeeping tasks, such as cleaning parking lot, loading dock and area surrounding building, keeping floors clear of debris, maintaining bathrooms and assisting in daily closing down of warehouse
