- Propose methods and programs for improving accounting systems and processes in the plant. Recommend measures to improve the financial results of the Clinton plant.
- Coordinate and support external and internal audits and afterwards lead the audit finding corrections process with necessary actions.
- Provide Leadership and Integrity as the financial and compliance voice at the Clinton plant.
- Training, development, and management of accounting team.
- Local Key User for SAP- Financial Accounting (FI) Module, which encompasses the recording, summarizing, and reporting of financial transactions for Clinton Truck Tire Plant.
- Participate in inventory counts
- Perform other duties as directed by Head of Controlling & Accounting.
