- 3) Lead business continuity planning (BCP) for critical supply chains.
- 4. Digital Transformation & Process Optimization
- 1) Leverage Al/analytics tools for supplier risk prediction, spend analysis, and procurement automation.
- 2) Drive ERP/SRM system enhancements to improve supplier onboarding, PO automation, and invoice reconciliation
- 3) SCM Supplier coach: improvement project for cost reduction, and delivery performance improvement
