- Lead the implementation of sustainability initiatives in the APAC region (e.g., decarbonization, circular economy, due diligence) by collaborating with internal stakeholders and suppliers
- Manage sustainability audit findings in the APAC region and ensure ongoing compliance with relevant environmental and human rights standards (e.g., ISO14001, SA8000). Support sustainability audit conduction on demand.
- Manage and develop relationships with internal and external stakeholders and with team and project members
- Address and rectify non-compliance incidents in coordination with suppliers and internal teams, ensuring alignment with corporate sustainability goals.
- Develop and deliver training programs and workshops to build supplier capabilities in sustainability practices, including renewable materials, decarbonization and circularity.
- Support the development and execution of stakeholder engagement strategies, including change management and communication plans, to embed sustainability into purchasing processes.
- Track and evaluate the effectiveness of sustainability projects and supplier improvement plans, using data-driven insights to inform continuous improvement.
- Maintain up-to-date knowledge of carbon markets, sustainability regulations, and industry best practices to advise internal teams and contribute to strategic planning.
