- Evaluation of bids, preparation of bid comparisons, cost and price analysis, independent execution of award negotiations and preparation of award decisions as well as the preparation of contract documents
- Preparation and documentation of the sourcing decision to ensure the necessary transparency and documentation of the award decision with regard to compliance guidelines and risks for the business process
- Presentation/implementation of alternative sources of supply and ensuring synergies by bundling volumes
- Determination of a strategic supplier pool in coordination with the responsible category manager, to ensure an optimal supply chain
- Supplier evaluation as a measure to optimize and monitor the defined supplier pool
- Work with Business Partners on the sourcing of products and services based on defined spend limits and corporate policies. Identify, initiate, accompany and tender Projects in cooperation with Category
