- Develop and implement risk management strategies to minimize legal exposure for Continental
- Analyze and address legal implications of new or revised regulations on Continental's business operations in and outside of Korea
- Provide proactive legal guidance and counsel to support the launch of new products or business initiatives by Continental
- Manage various types of litigations relating to matters concerning Korean customers and business partners
- Support other legal matters and topics concerning Continental's businesses in Korea as may be required from time to time as a member of the Korea Law Department
