- Provide legal training and guidance to various business colleagues, particularly in relation to contracts and business practices with Korean customers and business partners
- Represent in legal disputes, negotiations, and settlements with external parties, including Korean customers and business partners, suppliers, and regulatory authorities
- Develop and implement risk management strategies to minimize legal exposure
- Analyze and address legal implications of new or revised regulations on business operations in and outside of Korea
- Provide proactive legal guidance and counsel to support the launch of new products or business initiatives
- Manage various types of litigations relating to matters concerning Korean customers and business partners
- Support other legal matters and topics concerning businesses in Korea as may be required from time to time as a member of the Korea Law Department

- Strong knowledge of Korean laws and regulations, preferably those relevant to the automotive industry
