- Classifying products to ensure accurate legal customs tariff classification, including submitting requests for binding tariff information.
- Ensuring efficient, timely, and secure management of transport processes (customs, suppliers, and internal/intercompany logistics).
- Ensuring stable transport processes in accordance with country-specific requirements in coordination with nominated service providers.
- Maintaining and checking shipping notices and transit times with carriers.
- Notifying carriers of delivery changes from suppliers to customers in case of short-term adjustments.
- Executing standard customs clearance procedures.
- Manage transport damage and complaints (e.g., investigating cause, determining liabilities, and coordinating claim settlements).
- Coordinating import and export processes during emergency shipments (e.g., hand-carries, charter flights).
- Supporting first-level escalation by analyzing non-performance issues of service providers (e.g., delivery delays or inaccuracies).
- Monitoring results, maintaining accurate records, and distributing information to relevant business partners (e.g., customs authorities, freight forwarders, internal departments, suppliers, customers).
- Analyzing and improving transport processes using standardized IT systems and tools (e.g., optimizing contracted tariffs and terms for economic efficiency).
- Monitoring freight costs (actual vs. budgeted).
- Analyzing quotes from national and international freight carriers in coordination with central responsible functions.
