Supervise Passenger Tire Builders, Truckers, Setup Technicians, Precure Prep, TRU, and Check Tire Clerks insuring a high level of quality, efficiency, and safety is achieved.

1. Responsible for scheduling builder machine alignment.
2. Recording builder attendance and builder related defects.
3. Monitor quality, safety, productivity and housekeeping.
4. Responsible for coordinating schedule changes.
