Key Responsibilities:

- Develop and implement a global tax strategy to optimize the company's tax position, in close coordination with business areas, in support of the company's strategic goals.
- Oversee and manage transfer pricing strategies to ensure compliance with international regulations and minimize tax risks.
- Take responsibility for tax accounting, including ensuring accurate recognition and reporting of tax positions in financial statements.
- Identify and mitigate tax risks by implementing monitoring and control processes.
- Ensure compliance with national and international tax regulations, including the management of VAT and other indirect taxes.
- Promote international alignment and collaboration with tax teams in various countries to ensure consistent tax policies and practices.
- Collaborate with legal, finance, and business operations teams to advise on the tax implications of new business initiatives and product launches.
- Manage tax audits and disputes and interact with tax authorities.

Requisitos

- Academic degree in Accounting, Finance, Tax, Law or a related field. A Master's degree in Tax or Law is preferred
- German tax advisor - Exam ("Steuerberater") required
- broad and extensive professional experience, thereof several years in a senior leadership tax position, ideally within a global industrial company with a billion sales volume
- Deep knowledge of international tax regulations, strong understanding of GAAP/IFRS tax accounting, and proven experience in managing tax audits and relationships with tax authorities
