It includes leading the domestic tax department as well as providing professional leadership and guidelines to international tax teams. The Head of Group Tax ContiTech reports directly to the CFO and works closely with other departments and international teams to ensure a consistent and compliant tax policy.

Key Responsibilities:

- Develop and implement a global tax strategy to optimize the company's tax position, in close coordination with business areas, in support of the company's strategic goals.
- Oversee and manage transfer pricing strategies to ensure compliance with international regulations and minimize tax risks.
- Take responsibility for tax accounting, including ensuring accurate recognition and reporting of tax positions in financial statements.
- Identify and mitigate tax risks by implementing monitoring and control processes.
- Ensure compliance with national and international tax regulations, including the management of VAT and other indirect taxes.
- Promote international alignment and collaboration with tax teams in various countries to ensure consistent tax policies and practices.
- Collaborate with legal, finance, and business operations teams to advise on the tax implications of new business initiatives and product launches.
- Manage tax audits and disputes and interact with tax authorities.
