- Send shipping data to vendors to be uploaded for trailer inspections.
- Store and maintain records for 10 years as required.
- Assist in loading truck as needed to supply the market with our product.
- Accurately receive, store, and process transactions material shipped or received.
- Follow standard practices and perform all work promptly and accurately, obtaining quality and productivity objectives.
- Remain flexible to work where need arises.
- Supervise Shipping clerks to ensure daily duties and load monitoring is completed.
- Be the back to the warehouse Superintendent.
- Follow all plant, environmental, safety, quality, and departmental policies.
