- Ensure data lifecycle management and archiving, monitoring, and analysis of encryption protocols and events.
- Manage and maintain the defined Sensitivity Label and Sensitive Information Types (SIT).
- Implement improvements and changes to the MS DRM solution to protect digital content across various platforms and devices.
- Develop and maintain documentation for DRM configurations, processes, and procedures.
- Ensure compliance with industry regulations and content protection standards.
