- Participate in internal and external audits and support the corrective actions following the audits
- Implement and maintain process for regular usage of related Quality tools (e.g. FMEA, CP, A3, 8D)
- Manage, lead direct reports, train and develop the staff
- Implement processes and projects to drive prevention of incidents in the manufacturing area
- Support the problem solving culture in the plant by ensuring high quality of structured problem solving in own area
- Preparation of regular quality reports (control charts, trend charts...)
- Lead activities in the performance of special evaluations of product and process characteristic
