Oversees green tire inventory, flow, and curing coordination on an assigned shift, ensuring production continuity, quality compliance, and on-time delivery. Serves as a safety-focused liaison between operations, maintenance, and leadership while supporting problem-solving, training, and team effectiveness.

- Coordinate tire flow, sequencing, and phase-in/phase-out activities to support curing operations
