- Analyze manufacturing variances, standard costs, fixed costs, and balance sheet items, identifying deviations from budget, forecast, or standard and supporting corrective actions.
- Investigate manufacturing cost issues and support the development of methods, processes, and programs to improve the plant's financial performance.
- Support the month-end closing, forecast, and budget processes, including reconciliations, variance analysis, and preparation of supporting schedules.
- Assist in the preparation of detailed budgets and forecasts, ensuring alignment with business objectives and plant financial targets.
