You will work closely with management, external tax consultants, and fiscal authorities to provide guidance and lead key tax projects across multiple jurisdictions.

Key Responsibilities:

- Provide tax support for designated foreign countries, ensuring compliance with local tax regulations
- Monitor and analyze international tax law changes, assess their impact on the group, and communicate key updates to internal stakeholders
- Review and assist with the Tax Reporting of subsidiaries, ensuring timely and accurate registration
- Participate in tax projects such as liquidations, mergers, tax audits, and restructurings
- Review group structures to ensure alignment with corporate goals, and assist in necessary restructuring
- Maintain regular contact with colleagues in foreign subsidiaries, providing ongoing support for business operations and projects
- Support tax audits by German and foreign tax authorities, ensuring compliance and resolution of issues
- Act as the primary tax contact for foreign tax authorities and coordinate with international colleagues on tax matters
- Analyze tax consequences of reorganizations and provide guidance on potential impacts
- Collaborate with external tax advisors to address complex tax questions and issues
- Prepare and submit applications for tax certificates of residence for German group companies, liaising with the responsible German tax authority
