1. Position Summary

- Translate central infrastructure strategies, requirements, and technical standards into actionable steps for Local IT.
- Represent Local IT needs, constraints, and risks to central teams, ensuring they are considered in global planning and execution.
- Collect local constraints, risks, and dependencies and communicate them clearly to central teams.
- Support lifecycle management of servers and infrastructure services (updates, patching, decommissioning, compliance).

- Support project planning, readiness checks, execution monitoring, and post implementation validation.
