- **Create an Ergonomics Continuous Improvement Plan** Outline targeted improvements, training needs, and long term strategies.
- **Deliver a Final Presentation to Leadership** - Summarize your findings, recommendations, and project impact in a professional presentation to the management team at the end of your internship.
