As a **Maintenance & Engineering Intern**, you'll help transition legacy inspection records into digital systems, develop mapping and numbering tools that improve site navigation, and support space planning initiatives that directly impact daily operations.

- **Digitizing Regulatory Records** – Convert inspection documents such as pressure vessel inspections, railroad crossing inspections, and other compliance related records into digital formats for long term storage and accessibility.
- **Preventive Maintenance Integration** – Incorporate inspection frequencies and requirements into the preventive maintenance (PM) system to support timely scheduling and compliance tracking.
- **Pressure Vessel Mapping** – Create clear, accurate location maps for all pressure vessels to support inspections, maintenance, and regulatory audits.
- **Building Numbering System** – Develop a standardized building numbering system to replace letter based identifiers, improving clarity for employees, contractors, and emergency responders.
- **Racking Layout Development** – Design a racking plan using existing racking from another location, ensuring efficient use of space and alignment with operational needs.
- **End of Internship Leadership Presentation** – Deliver a polished, professional presentation to the management team summarizing your findings, recommendations, and project impact.
