- Coordinate with the Credit Analyst regarding account unlocks, delivery holds, and reconciliation issues
- Update and maintain the Accounts Receivable overdue dashboard weekly with data-driven recommendations

Commission, Rebate & Month-End Processing

- Review and validate commission payment reports with delivery evidence verification
- Generate early payment calculations and coordinate
