- Responsible for segregation and blocking of off-standard products/semi- products/process/machine by following controlled nonconforming procedures
- Analyze quality relevant processes in case of quality deviations, in cooperation with production and process
- Performance of special evaluations of product and process characteristics and preparation of quality records (control charts, trend charts...)
- Follow all plant, ESH, CBS, quality, and department processes and procedures
- Other duties as assigned
