- Posting and reconciliation of bank accounts, including manual payments, payment runs, and clearing activities
- Processing of special payment transactions and intercompany netting

#### General Ledger, Closing & Reporting

- Independent execution and maintenance of general ledger postings within the assigned scope
- Reconciliation and analysis of balance sheet and P&L accounts
- Support in monthly, quarterly, and annual financial statements in accordance with IFRS and HGB
- Posting of accruals, provisions, and valuation entries
- Ensuring compliance with accounting policies, internal controls, and regulatory requirements
- Handling of Bundesbank reporting (e.g. Z4, ZM)

#### Collaboration & Projects

- Close coordination with subledger teams (AP, AR, Fixed Assets, Bank Accounting)
- Contact person for accounting-related inquiries within the organization
- Collaboration with Controlling, Tax, Treasury, and other finance functions
- Interface for external auditors and internal audit
- Contribution to process improvements, finance projects, and system optimizations, particularly in SAP FI / S/4HANA
