- Conduct internal incident investigations and proactively initiates corrective actions to prevent recurrence.
- Supports the planning and implementation of a local audit procedure to control and check regularly for conformity and continuous improvement potential of the ESSH management system according to ISO 45001 / OSHA requirement.
- Responsible to close all audit findings from internal and external audits for the area of ISO 45001 in the defined timeframe.
- Participate in other audits as needed e.g. environmental or other plants
- Develop and keep up to date the required training material for the Safety and Health management area.
- Ensure training and qualification of all involved employees for the Safety and Health systems including the record keeping.
- Develop and communicate Health awareness campaign for the complete plant
- Drives the development and implementation of health and wellness programs that promote employee well-being.
- Coordinate wellness activities, ensure proper PPE (Personal Protective Equipment) usage, and provide training on health hazards.
- Ensure the systematical ergonomic evaluation of all existing workplaces together with the IE team.
- Drives the development of the needed technical improvement measures.
- Support the evaluation of technical measures, plan the needed investment and ensure that the roll out is being done in a timely
