- Ensure the effective implementation of preventive maintenance schedules, inspections, lubrication programs, and equipment adjustments.
- Coordinate breakdown response activities and lead efforts to restore equipment availability quickly and safely.
- Assist with root cause analysis investigations and implement corrective actions to prevent recurring equipment failures.
- Assign daily work, monitor technician performance, and foster a culture of accountability, teamwork, and continuous technical development.
- Support the onboarding and training of new maintenance personnel.
- Ensure compliance with Environmental, Safety, and Health (ESH) requirements, including lockout/tagout procedures, safe work practices, and housekeeping standards.
- Participate in safety inspections, audits, and incident investigations.
- Maintain accurate maintenance records, work orders, inspections, and repair documentation within SAP-PM or other maintenance management systems.
- Monitor spare parts usage and communicate material requirements to maintenance management.
- Support continuous improvement initiatives, Total Productive Maintenance (TPM) activities, and maintenance process optimization efforts.
- Collaborate with Production, Engineering, Quality, and Purchasing teams to support operational goals, equipment reliability, and technical improvement initiatives.
