Setup adjust Final Finish equipment to include, but not limited to, TUO, Micro-poise, Balance Grinders, Conicity Grinders, SOL, Geometry, Gantry controls, etc.

1. Setup, detect, and adjust and correct equipment using electrical, mechanical and pneumatic knowledge, of TUO, bouncers, sheet of light and geometry.
2. Make all necessary setups and adjustments following company standards.
3. Observe and make necessary machinery adjustments to assure continuous operations. Supervise the first tire/tires run following a setup or adjustments and approve for production.
4. React quickly to equipment downtime or other extraordinary condition, and must notify supervision whenever such conditions occur.
