- Drive the SPC process in the preparation areas.
- Esurance of quality management systems compliance in the preparation areas.
- Leading and directing a small group of quality inspectors.
- Annual budget control for Quality Management in Calendering and Preparation areas.
- Be facilitator structure problem solving and ambassador of quality behavior award.

Reporting and Evaluation

- Preparation of quality records (control charts, trend charts...).
- Lead activities in the performance of special evaluations of product and process characteristic.

ESH

- Ensure implementation of measures and maintain control.
- Raise awareness and provide information about ESH responsibilities and duties.
- Ensure immediate notification and response, and initiate preventive measures in case of unsafe or polluting hazards.
- Demonstrate exemplary personal behavior in ESH and motivate others.
