- Process shipments from non-EU countries for release into free circulation, including the preparation and submission of simplified customs declarations.
- Monitor incoming import shipments and perform daily goods receipt controls.
- Communicate and coordinate with internal business units, suppliers, freight forwarders, consignees, and warehouse operators.
- Prepare all customs-related documentation and support internal and external audits, including the review of customs invoices and tax assessments issued by external service providers.
- Provide customs-related advice and support to business units and affiliated group companies.
- Contribute to cross-functional activities, including reporting, projects, testing, and business release management.
